Due to the time sensitive nature of the request (as governed under the Act) and the confidential content of the request the Heart Institute was unable to follow the normal procurement process for these services.

HealthTech Consultants	UOHI IT Dept - EMR (Electronic Medical Record) Project	\$48,630	Nov 30, 2014	Sole Source Selection - TOH recently selected HealthTech via RFP to perform a Five Year IS Strategic Plan refresh. The outcome of that plan is that TOH and UOHI will be partnering on a shared EMR (Electronic Medical Record) project. In order to better understand UOHI's options with the project, we engaged HealthTech to provide further information, building upon the strategic plan, that will be used to more clearly understand the needs and options for the Institute.
